**Letter – in relation to the Hong Kong Investor Identification Regime and Over-the-counter Securities Transactions Reporting Regime and Fast Interface for New Issuance (“FINI”) a new platform to be implemented by Hong Kong Exchanges and Clearing Limited**

**客戶同意書——關於香港投資者識別制度和場外證券交易匯報制度及香港交易及結算有限公司開發的嶄新公開招股結算平台(“FINI”)**

Reference is made to the Consultation Conclusions Paper (“Conclusions”) on proposals to (i) implement an investor identification regime at trading level for the securities market in Hong Kong; and (ii) over-the-counter securities transactions reporting regime for shares listed on the Stock Exchange of Hong Kong (“HKEX”) on 10 August 2021 and other notifications from time to time, which may be implemented in 2022 and 2023 respectively, as stipulated by the Securities and Futures Commission of Hong Kong (“SFC”) and Hong Kong Exchange and Clearing Limited (“HKEX”) (collectively, the “Investor Identification Regime and OTCR”), and reference is made to the HKEX’s November 2020 FINI Concept Paper and July 2021 Conclusions Paper and other notifications from time to time to introduce new platform FINI, which may be implemented in 2022.

承於關於下述兩項諮詢的結論文件(“《結論》”) (i)就有關在交易層面上對香港證券市場實施投資者識別碼制度的建議, 以及(ii) 於 2021 年 8 月 10 日發佈的為在香港聯合交易所上市的股份引入場外證券交易匯報制度的建議, 和其他不時發出的通知, 香港證券及期貨事務監察委員會(“證監會”)及香港交易及結算有限公司(“聯交所”)將會分別於 2022 年和 2023 年進行實施相關規定(“投資者身份識別制度和場外證券交易匯報制度”)。承於聯交所於 2021 年 7 月刊發對 2020 年 11 月 FINI 框架諮詢文件的諮詢總結, 和不時關於引進新平台 FINI 的通知, FINI 將在 2022 年實施。

I hereby confirm to you, CF International Securities Company Limited, that I have given my consent in respect of the processing of my personal data in connection with my account(s) (the “Accounts”) and your services to me, including without limitation, those as provided in the Privacy Policy Statement.

Without limiting to the foregoing, by signing this consent letter, I agree and acknowledge that you and/or your affiliates may assign Broker-Client Assigned Number (the “BCAN”) to me to provide services to me in relation to securities listed or traded on the HKEX and for complying with the rules and requirements of HKEX and/or SFC in effect from time to time (including but not limited

to the Conclusions and the Code of Conduct for Persons Licensed by or Registered with the SFC (the "Code of Conduct"), and I further agree and consent expressly that you and/or your affiliates may collect, store, process, use, disclose and transfer personal data relating to me (including my client identification data (the "CID") and BCAN(s)) as required for CFIS to provide services to me in relation to securities listed or traded on the HKEX and for complying with the rules and requirements of the HKEX and/or the SFC in effect from time to time (including but not limited to the Conclusions and the Code of Conduct), and to provide services for the subscription or purchase of securities in a public offer in respect of a new listing on the HKEX, including, without limitation, as follows:

在不限於上述規定的情況下，通過簽署本同意書，本人同意並承認貴司和/或貴司的關聯公司可將券商客戶編碼（“券商客戶編碼”）分配給本人，以向本人提供與在聯交所上市或交易的證券有關的服務，並遵守聯交所和/或證監會不時實施的要求（包括但不限於《結論》和《證券及期貨事務監察委員會持牌人或註冊人操守準則》（“《行為守則》”）。本人同意並明確同意貴司和/或貴司的關聯公司可以收集、存儲、處理、使用、披露和傳輸與本人有關的個人資料（包括本人的客戶識別信息（“客戶識別信息”）和券商客戶編碼）以便信期證券向本人提供與在聯交所上市或交易的證券有關的服務，並遵守聯交所和/或證監會不時實施的要求（包括但不限於《結論》及《行為守則》），為提供與在聯交所新上市的公開發售中認購或購買證券相關的服務，其中包括，但不限於以下內容：

- a) disclosing and transferring my personal data (including CID and BCAN(s)), directly or indirectly through another broker or other intermediaries you may use in relation to the services you provide to me (if any), to Hong Kong Securities Clearing Company Limited (HKSCC), HKEX and/or the SFC in accordance with the rules and requirements of HKSCC, HKEX and the SFC in effect from time to time;

根據香港中央結算有限公司（“結算所”）、聯交所及證監會不時實施的條例及要求，貴司向本人提供服務時，直接或間接地透過其他經紀人或其他中介人向結算所、聯交所及證監會披露及傳輸本人的個人資料（包括客戶識別信息及券商客戶編碼）；

- b) allowing HKEX to: (i) collect, store, process and use my personal data (including CID and BCAN(s)) for market surveillance and monitoring purposes and enforcement of the Rules of the Exchange of HKEX; and (ii) disclose and transfer such information to the relevant regulators and law enforcement agencies in Hong Kong (including, but not limited to, the SFC) so as to facilitate the performance of their statutory functions with respect to the Hong Kong financial markets; and (iii) use such information for conducting analysis for the purposes of market oversight; and

允許聯交所：(i)收集、儲存、處理及使用本人的個人資料（包括客戶識別信息和券商客戶編碼），以便監察、監督市場及執行《聯交所規則》；(ii)向香港相關監管機構和執法機構（包括但不限於證監會）披露及轉移有關資料，以便他們就香港金融市場履行其法定職能；及(iii)以監察市場為目的而使用有關資料進行分析；

- c) allowing the SFC to: (i) collect, store, process and use my personal data (including CID and BCAN(s)) for the performance of its statutory functions including monitoring, surveillance and enforcement functions with respect to the Hong Kong financial markets; and (ii) disclose and transfer such information to relevant regulators and law enforcement agencies in Hong Kong in accordance with applicable laws or regulatory requirements; and

允許證監會：(i)收集、儲存、處理和使用本人的個人資料（包括客戶識別信息和券商客戶編碼），以履行其法定職能，包括對香港金融業務的監控、監督和執法；(ii)根據

適用法律 或監管要求，向香港的相關監管機構和執法機構披露和傳輸此類信息；及

d) providing BCAN to HKSCC allowing HKSCC to: (i) retrieve from HKEX (which is allowed to disclose and transfer to HKSCC), process and store my CID and transfer my CID to the issuer's share registrar to enable HKSCC and/ or the issuer's share registrar to verify that you have not made any duplicate applications for the relevant share subscription and to facilitate IPO balloting and IPO settlement; and (ii) process and store my CID and transfer my CID to the issuer, the issuer's share registrar, the SFC, HKEX and any other party involved in the IPO for the purposes of processing my application for the relevant share subscription or any other purpose set out in the IPO issuer's prospectus.
