## 條款及細則 Terms and Conditions:

1. 申請報價服務，開通需時大概兩個工作天。  
Application of Quotation Service will take around 2 working days to activate.
2. 如客人開通網上股票交易服務及沒有選取指定報價系統時，將可免費享用延遲報價服務。  
When client activates the Online Securities Trading Service without choosing any real time quote (“RTQ”) service, it will default using Delay service.
3. 國內版本只適用於在中國大陸境內瀏覽即時行情的客戶。若於中國大陸以外登入，則不能使用即時報價服務，下單操作則維持正常。China Client Package is only applicable for checking RTQ in China Area. Client will not be able to use the RTQ service in the out of China area but the internet trade service will remain effective.
4. 客戶授權本公司可以將其地址及身份證明資料供給相關的報價系統公司或相關的交易所以作核實客戶身份之用途。  
We are authorized to provide client’s address and ID information to related Vendor or related Exchanges for verifying client’s identity.
5. 客戶承認所有服務和內容的版權和歸屬，包括任何已提供的軟件是屬於有關服務供應商所持有，任何對上述財產的複製，分發和竄改均構成或對本條款及細則的違約行為。  
Client acknowledges that the title to, copyright and all other intellectual property rights in the Services, including any software provided and any improvements or modifications, are and shall remain vested in “Service Provider” and any reproduction, re-transmission or modification of these property shall constitute a breach of this Terms and Conditions.
